# [LEGISLATIVE COMPATIBILITY]

At present, the legislation imposes the obligation of printing and signing laboratory results. Specific responsible individuals with the appropriate authorisation sign the printed results at the designated times. In accordance with Health Services Act no. 372/2011 and Healthcare Documentation Regulation no. 98/2012 Coll., it is possible to maintain healthcare documentation in a fully electronic form given the fulfilment of the prescribed conditions.

The Paper-Free Laboratory Daily Log solution meets all of the conditions required by the legislation, such as the realisation of back-ups within set intervals, saving data at several independent storage sites, encryption or the conditions applied to shredding management.


# [ALL-IN-ONE]

In practice, this means substantial financial savings on printing and the operation of the print infrastructure, the significant acceleration and simplification of the process and the extension of its validity and security.

The solution stands out thanks to its exceptionally simple implementation and integration with the environs. It can be easily connected to a number of information systems thanks to a number of standardised integration mechanisms.

### [THE COMPONENTS IN THE SOLUTION ]

The entire solution is supplied as a fully compact unit. This eliminates any costly, time consuming and risky implementation.

The hardware is a standard part of the solution including tested and safe components ensuring the legislative compatibility considering eg. the multiplication of the physical data storage points, the realisation of back-ups and so on.

The adapter is the solution's communication component, which enables standardised integration with any laboratory information system. This component receives the results from the laboratory in electronic form and ensures that they are signed, time-stamped and sent to the archive in the internationally standardised and secure PDF-A format.

The results from the laboratory's information system are accepted both in the DASTA format and in the PDF format with an additional XML file with the patient's metadata.


Long-term, secure and trustworthy archiving is the component responsible for the secure, fully digital archiving of the results while fulfilling all the legislative conditions.

The solution includes tools for re-stamping documents with the time stamp at the prescribed intervals in accordance with the legislature and mechanisms for multiple back-ups, data encryption or the realisation of legislatively compatible shredding.
